



ATV / GOLF CART/ PIT BIKE REGULATIONS

Permit Application Form

The rules and regulations listed below are to be followed at all times. Operators of **ATV/Golf Cart/Pit Bike** understand that they do so at their own risk, and will relieve and hold harmless Adams County Speedway for any and all debts that might occur from theft, accidents and/or injuries involving the use of **ATV/Golf Cart/Pit Bike**. These rules have been designed to provide a safe and friendly environment for all persons attending events at Adams County Speedway.

ATV / GOLF CART / PIT BIKE REGULATIONS

1. All full size **ATV/Golf Cart/Pit Bike** on Adams County Speedway property must display official permit at all times. Permits are available at the infield tower.
2. All operators must be 16 years old and hold a valid driver's license and must be registered to a driver competing at the Adams County Speedway. Drivers allowed one **ATV/Golf Cart/Pit Bike** permit per pit pass.
3. No crew members, or fans can bring an **ATV/Golf Cart/Pit Bike** to the pits.
4. No riders on the **ATV/Golf Cart/Pit Bike** unless there is a designed seat for a passenger. No standing at the back of cart, No riding on handle bars, and no riders on front or back racks of ATV.
5. All full size **ATV/Golf Cart/Pit Bike** must be parked 30 minutes after the conclusion of the final race.
6. 10 mph speed limit at ALL times. All drivers must abide by the one way flow in the pits.
7. All full size **ATV/Golf Cart/Pit Bike** must have permission to be on the track during the races. Before the races and intermission is okay as long as you don't effect track preparations.
8. All full size **ATV/Golf Cart/Pit Bike** are not to be operated in a manner that may endanger passengers or any other patrons on the grounds of Adams County Speedway.
9. Race cars, track maintenance vehicles, all other vehicles and pedestrians have right away at all times.
10. No wreck less driving. Excessive speeds will not be tolerated.
11. **ATV/Golf Cart/Pit Bike** must not block entrances to buildings, roads, tow trucks or fire and safety.
12. Violation of these rules will result in the **ATV/Golf Cart/Pit Bike** being impounded for the remainder of the event, possible fines, permit revoked and possible expulsion of the operator and the driver from the property with NO REFUND.
- 13. All drivers are responsible for anyone who drivers their registered ATV/Golf Cart/Pit Bike.**
